

The relative strengths and weaknesses of CARLISLE COMPANIES INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of CARLISLE COMPANIES INC compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 164% points. The greatest weakness of CARLISLE COMPANIES INC is the variable Cost of Revenues, reducing the Economic Capital Ratio by 85% points.

The company's Economic Capital Ratio, given in the ranking table, is 139%, being 129% points above the market average of 10%.
