

The relative strengths and weaknesses of HIGHWATER ETHANOL LLC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HIGHWATER ETHANOL LLC compared to the market average is the variable Selling, General and Administrative Expense, increasing the Economic Capital Ratio by 281% points. The greatest weakness of HIGHWATER ETHANOL LLC is the variable Cost of Revenues, reducing the Economic Capital Ratio by 656% points.

The company's Economic Capital Ratio, given in the ranking table, is 49%, being 39% points above the market average of 10%.
