



The relative strengths and weaknesses of PIONEER NATURAL RESOURCES CO are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of PIONEER NATURAL RESOURCES CO compared to the market average is the variable Revenue from Contract with Customer, increasing the Economic Capital Ratio by 301% points. The greatest weakness of PIONEER NATURAL RESOURCES CO is the variable Other Expenses, reducing the Economic Capital Ratio by 244% points.

The company's Economic Capital Ratio, given in the ranking table, is 225%, being 172% points above the market average of 54%.
