

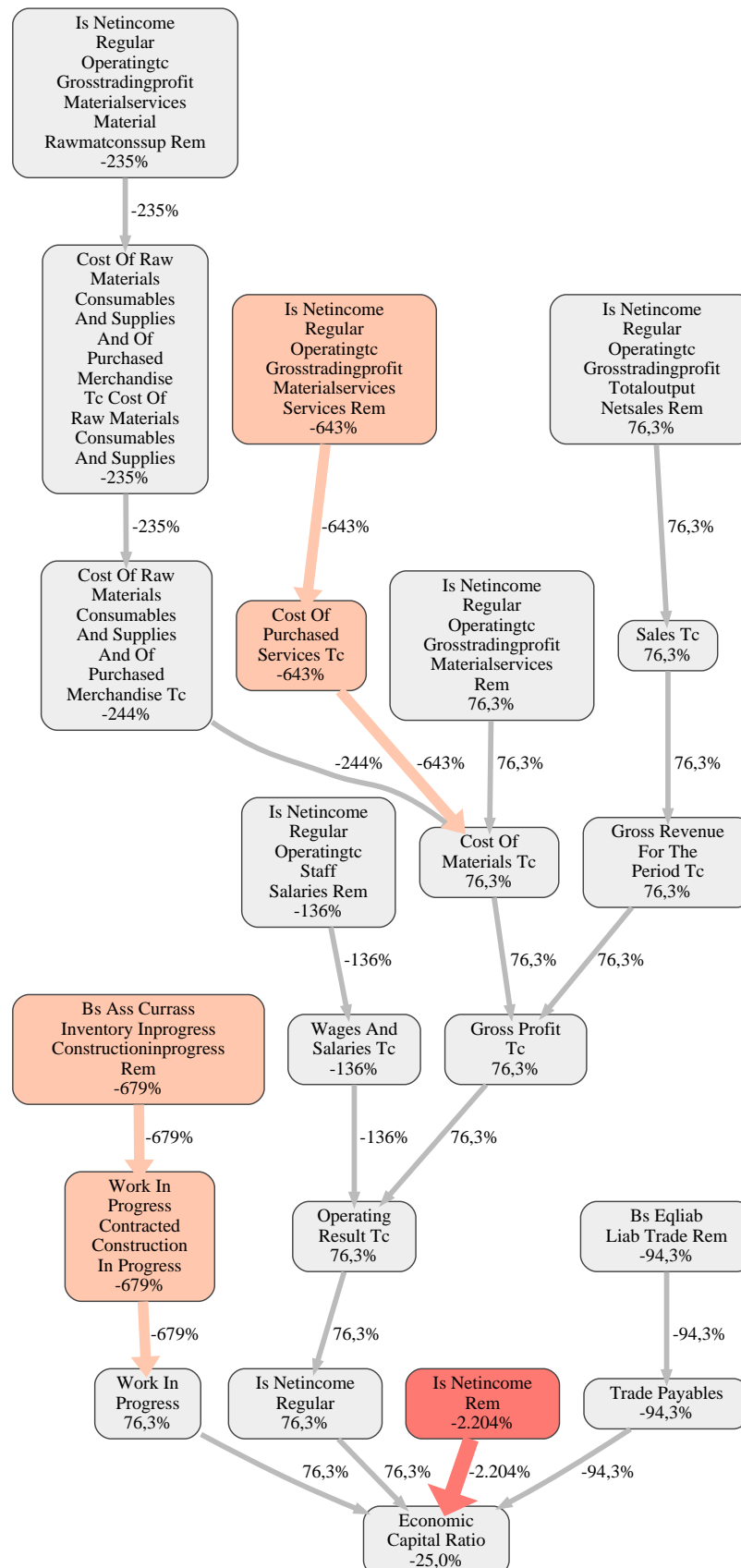

The relative strengths and weaknesses of Otto Mühlherr Baugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Mühlherr Baugesellschaft mbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 76% points. The greatest weakness of Otto Mühlherr Baugesellschaft mbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 2.204% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 25% points below the market average of 101%.
