



The relative strengths and weaknesses of Bauunternehmung Hermann GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Hermann GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Bauunternehmung Hermann GmbH is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Rem, reducing the Economic Capital Ratio by 3.361% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 16% points below the market average of 101%.
