



The relative strengths and weaknesses of Schrobsdorff Holding AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 211% points. The greatest weakness of Schrobsdorff Holding AG is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 325% points.

The company's Economic Capital Ratio, given in the ranking table, is 232%, being 131% points above the market average of 101%.
