



The relative strengths and weaknesses of HBG Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HBG Bau GmbH compared to the market average is the variable Bs Ass Fixass Fin Sharesinaffil Rem, increasing the Economic Capital Ratio by 28% points. The greatest weakness of HBG Bau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 253% points.

The company's Economic Capital Ratio, given in the ranking table, is 28%, being 74% points below the market average of 101%.
