



The relative strengths and weaknesses of Faber Schnepf Hoch und Tiefbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Faber Schnepf Hoch und Tiefbau GmbH Co KG compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 93% points. The greatest weakness of Faber Schnepf Hoch und Tiefbau GmbH Co KG is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 447% points.

The company's Economic Capital Ratio, given in the ranking table, is 93%, being 7,8% points below the market average of 101%.
