The greatest strength of Otto Wulff Bauunternehmung GmbH Konzern compared to the market average is the variable Bs Ass Currass Inventory Rem, increasing the Economic Capital Ratio by 110% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH Konzern is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 191% points.

The company's Economic Capital Ratio, given in the ranking table, is 110%, being 8,8% points above the market average of 101%.
