

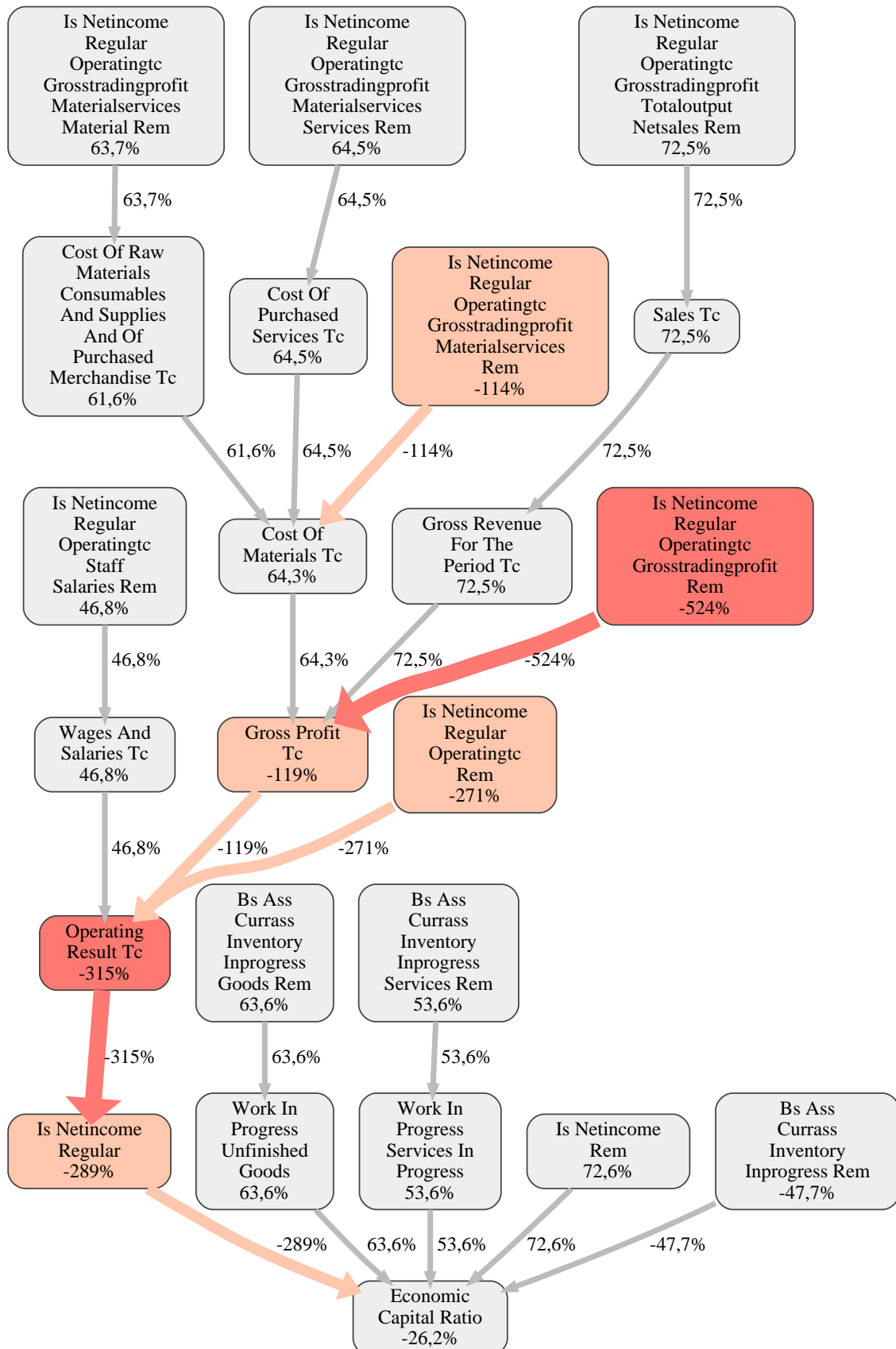

The relative strengths and weaknesses of VSTR AG Rodewisch are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 73% points. The greatest weakness of VSTR AG Rodewisch is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 524% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 26% points below the market average of 99%.
