



The relative strengths and weaknesses of Mark A Krüger Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Mark A Krüger Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 60% points. The greatest weakness of Mark A Krüger Bauunternehmung GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 227% points.

The company's Economic Capital Ratio, given in the ranking table, is 60%, being 39% points below the market average of 99%.
