

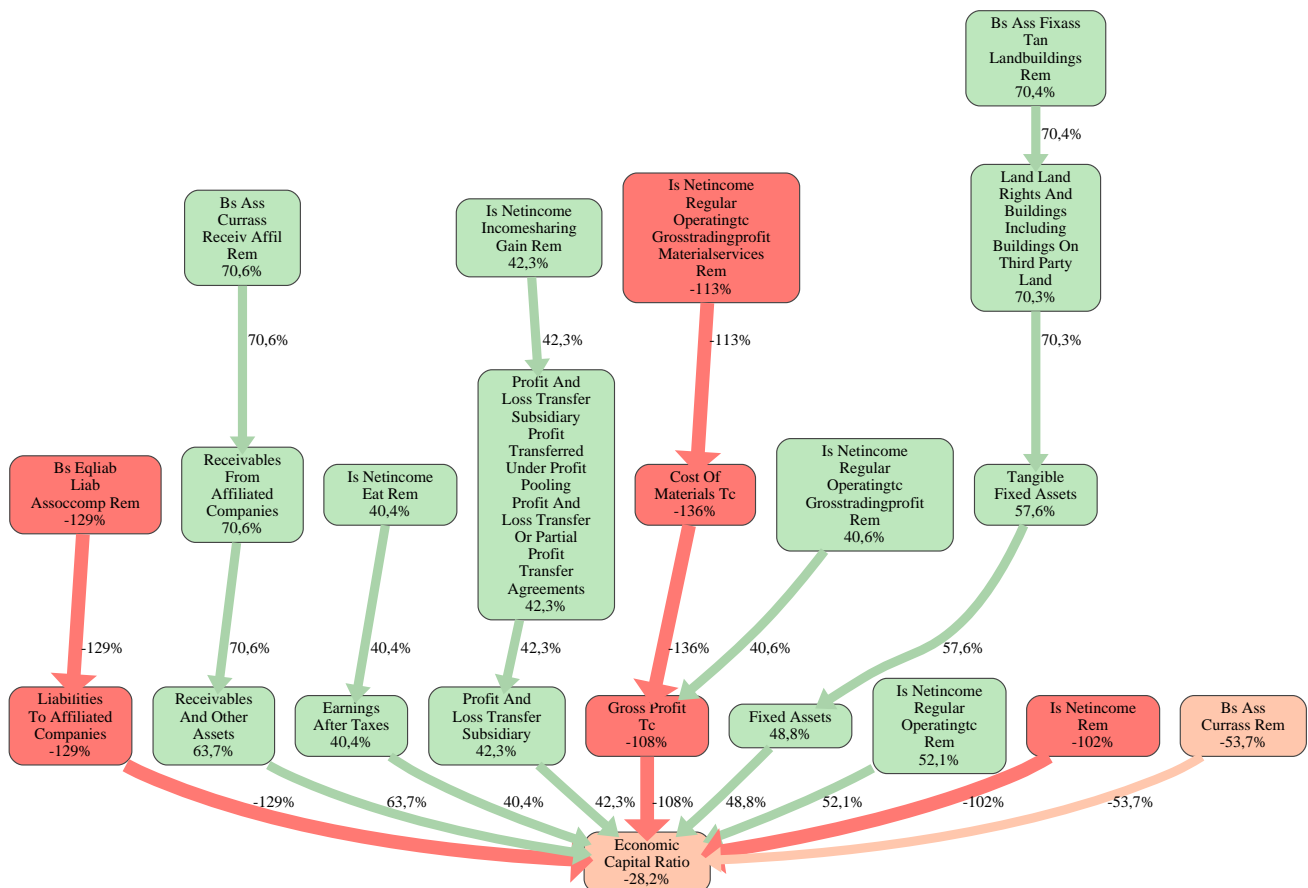

The relative strengths and weaknesses of SVI Vertriebs und Immobilien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SVI Vertriebs und Immobilien GmbH compared to the market average is the variable Bs Ass Currass Receiv Affil Rem, increasing the Economic Capital Ratio by 71% points. The greatest weakness of SVI Vertriebs und Immobilien GmbH is the variable Cost Of Materials Tc, reducing the Economic Capital Ratio by 136% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 28% points below the market average of 99%.
