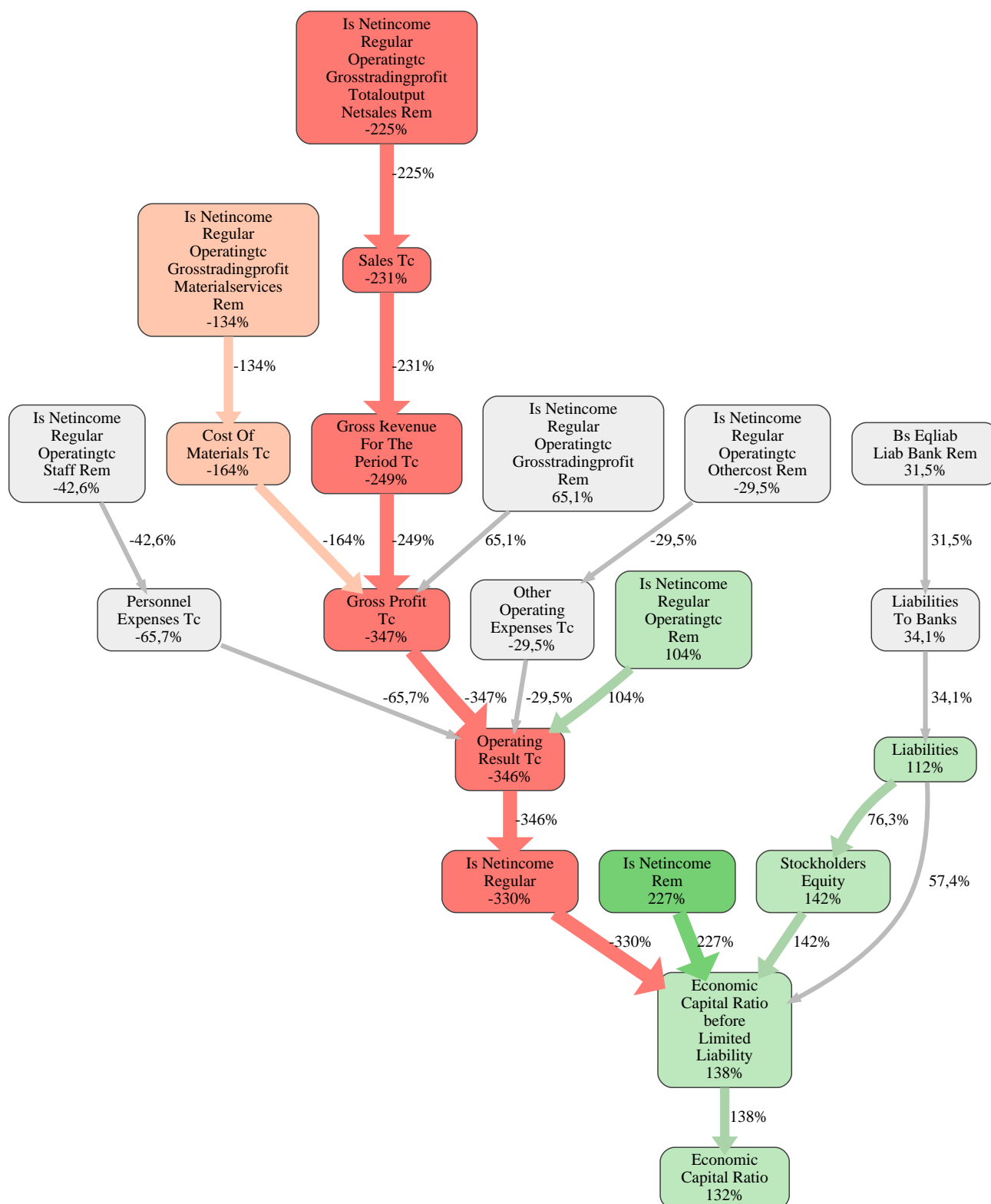

The relative strengths and weaknesses of Markgraf Familien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 227% points. The greatest weakness of Markgraf Familien GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 347% points.

The company's Economic Capital Ratio, given in the ranking table, is 231%, being 132% points above the market average of 99%.
