



The relative strengths and weaknesses of Tell Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Tell Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Tell Bau GmbH is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 254% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 29% points below the market average of 97%.
