The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 100% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Bs Ass Currass Inventory Inprogress Services Rem, reducing the Economic Capital Ratio by 745% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 3,6% points above the market average of 97%.
