



The relative strengths and weaknesses of Wunstorfer Bauverein Wohnungsbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wunstorfer Bauverein Wohnungsbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Staff Salaries Rem, increasing the Economic Capital Ratio by 0,0015% points. The greatest weakness of Wunstorfer Bauverein Wohnungsbau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 353% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,0015%, being 97% points below the market average of 97%.
