



The relative strengths and weaknesses of Faber Schnepf Hoch und Tiefbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Faber Schnepf Hoch und Tiefbau GmbH Co KG compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Rem, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Faber Schnepf Hoch und Tiefbau GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 161% points.

The company's Economic Capital Ratio, given in the ranking table, is 72%, being 30% points below the market average of 103%.
