



The relative strengths and weaknesses of Gelsenkirchener Gemeinnützige Wohnungsbaugesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gelsenkirchener Gemeinnützige Wohnungsbaugesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 57% points. The greatest weakness of Gelsenkirchener Gemeinnützige Wohnungsbaugesellschaft mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 458% points.

The company's Economic Capital Ratio, given in the ranking table, is 57%, being 49% points below the market average of 106%.
