

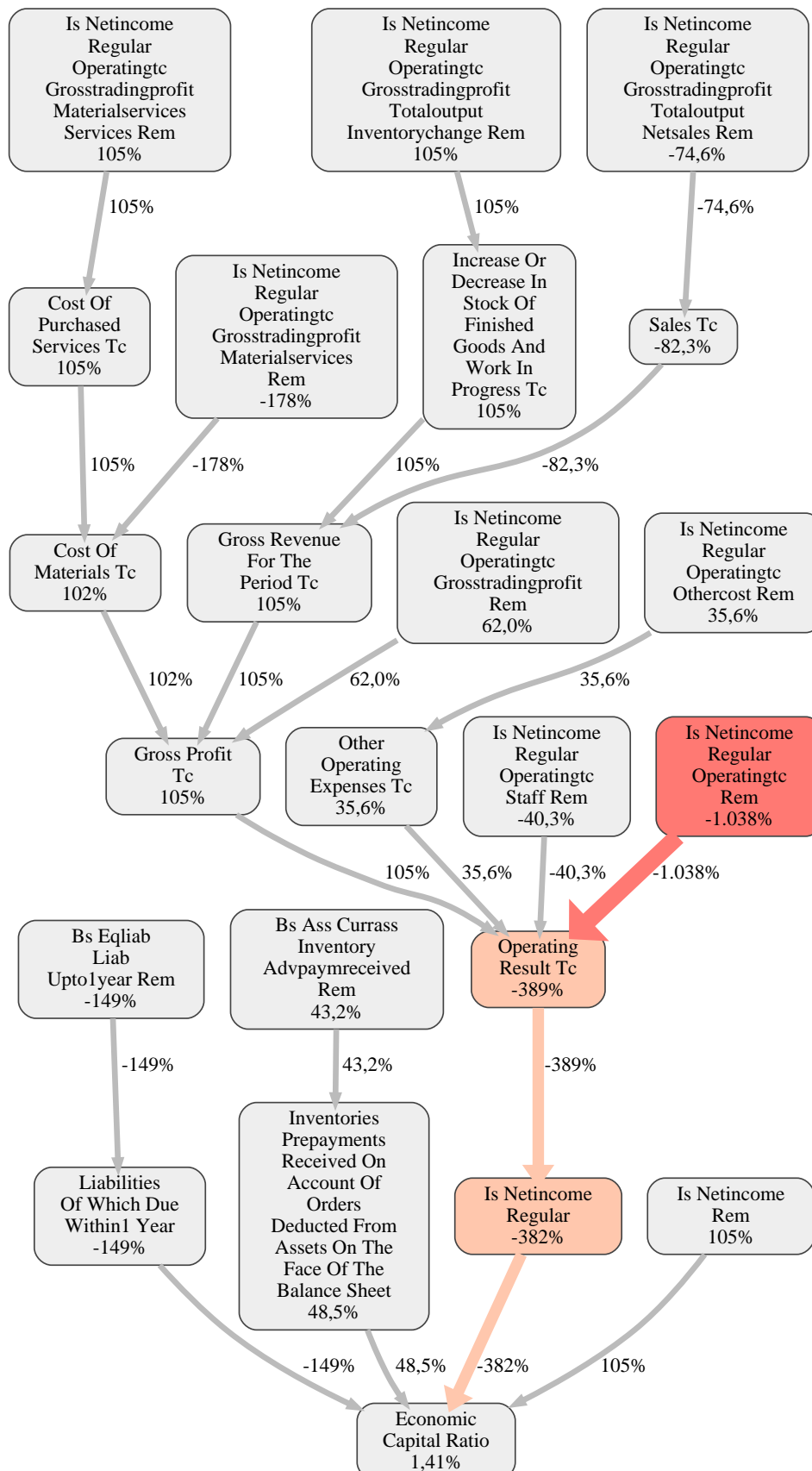

The relative strengths and weaknesses of Schrobsdorff Bau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Bau Aktiengesellschaft compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 105% points. The greatest weakness of Schrobsdorff Bau Aktiengesellschaft is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 1.038% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 1,4% points above the market average of 103%.
