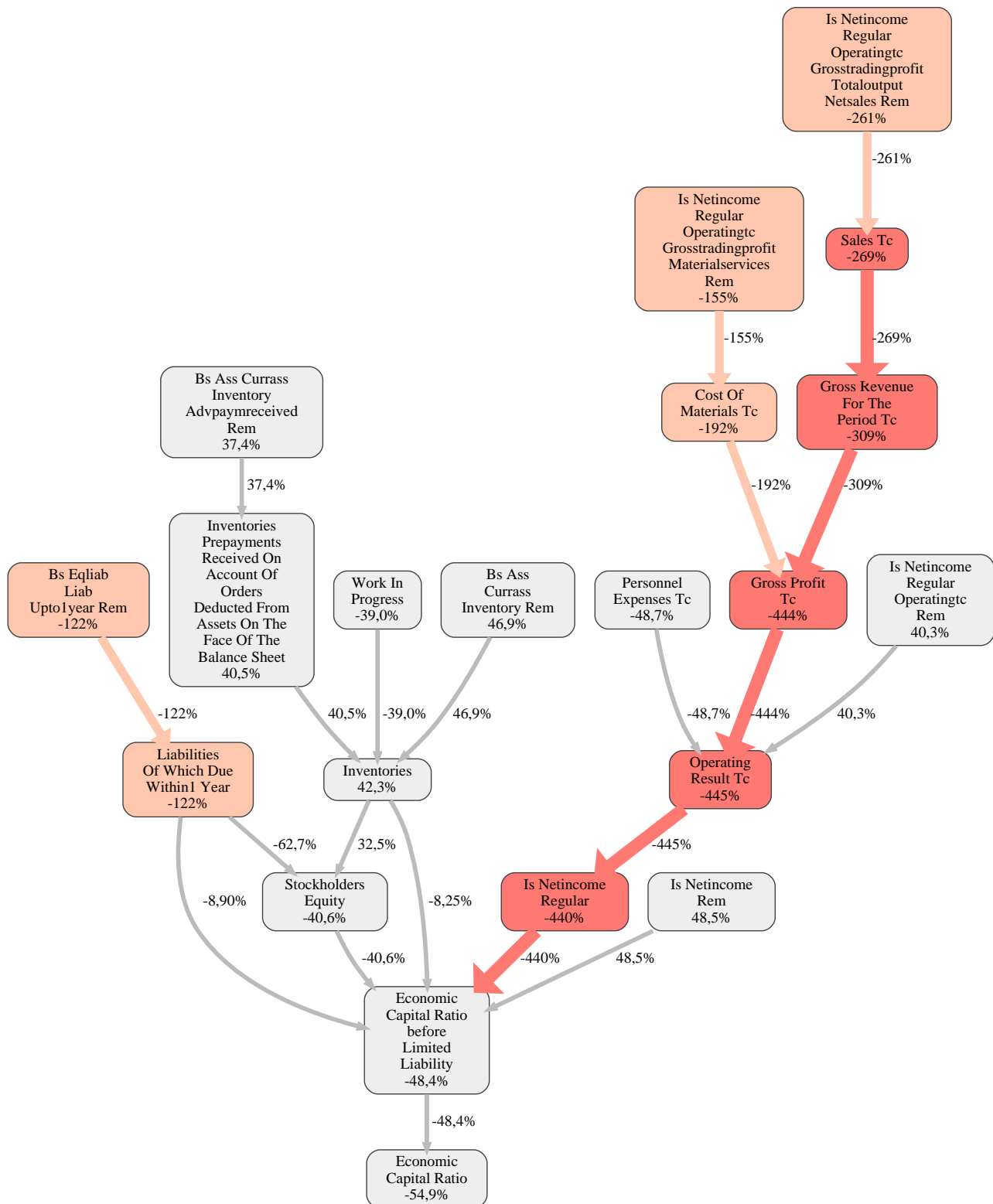

The greatest strength of Bauunternehmung Peter Igl GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 49% points. The greatest weakness of Bauunternehmung Peter Igl GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 445% points.

The company's Economic Capital Ratio, given in the ranking table, is 49%, being 55% points below the market average of 103%.
