



The relative strengths and weaknesses of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 115% points. The greatest weakness of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 466% points.

The company's Economic Capital Ratio, given in the ranking table, is 115%, being 12% points above the market average of 103%.
