



The relative strengths and weaknesses of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 128% points. The greatest weakness of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 626% points.

The company's Economic Capital Ratio, given in the ranking table, is 128%, being 25% points above the market average of 103%.
