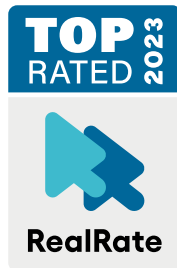

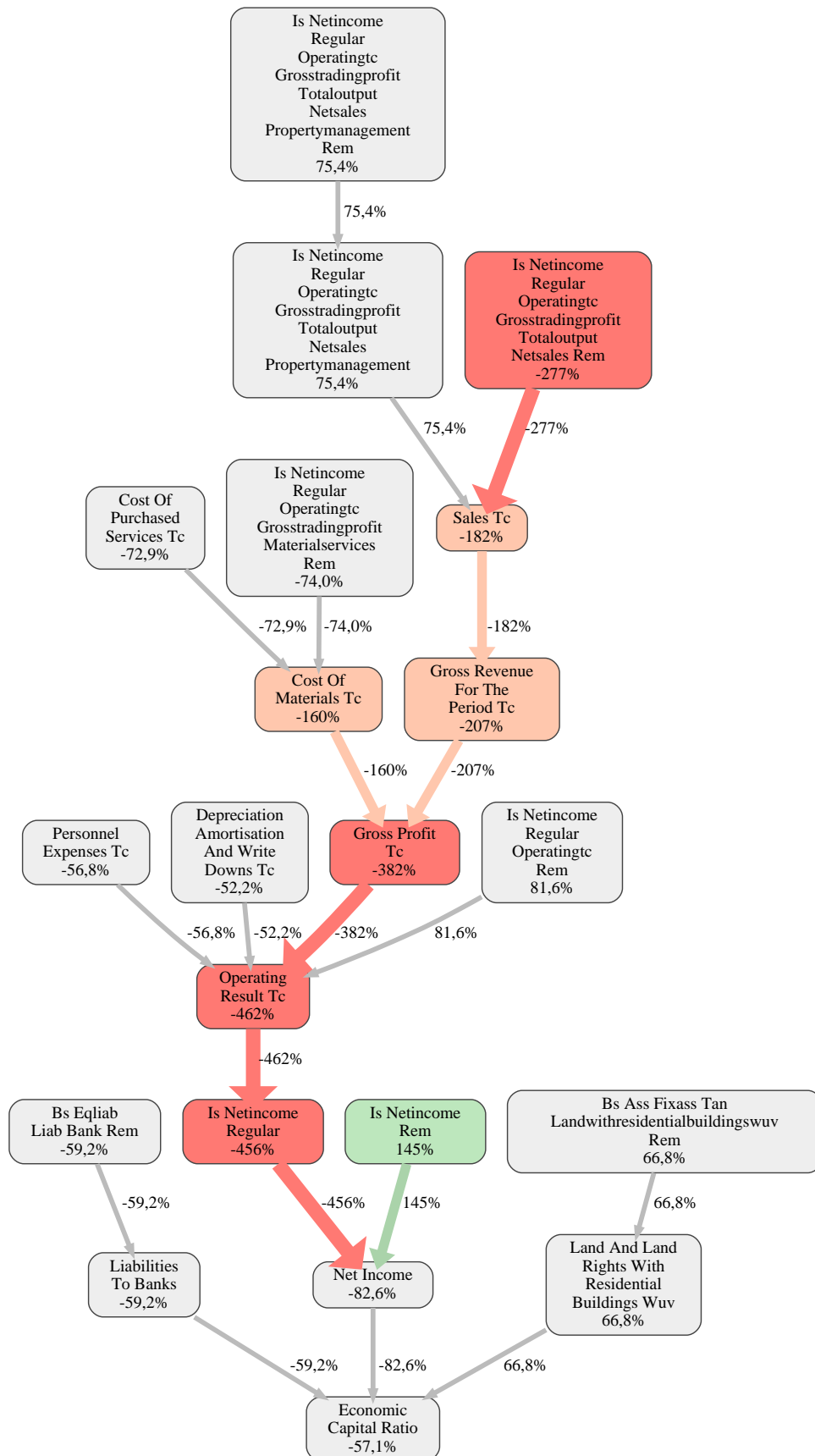

The relative strengths and weaknesses of DR Seifert Wilmersdorfer Hochbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of DR Seifert Wilmersdorfer Hochbau Aktiengesellschaft compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 145% points. The greatest weakness of DR Seifert Wilmersdorfer Hochbau Aktiengesellschaft is the variable Operating Result Tc, reducing the Economic Capital Ratio by 462% points.

The company's Economic Capital Ratio, given in the ranking table, is 145%, being 57% points below the market average of 202%.
