





The relative strengths and weaknesses of Xaver Lutzenberger GmbH Co KG Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Xaver Lutzenberger GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 171% points. The greatest weakness of Xaver Lutzenberger GmbH Co KG Bauunternehmung is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 392% points.

The company's Economic Capital Ratio, given in the ranking table, is 174%, being 28% points below the market average of 202%.
