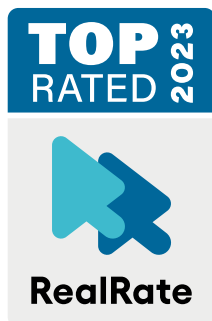

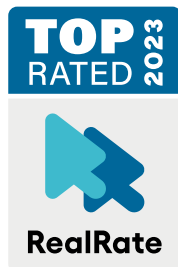

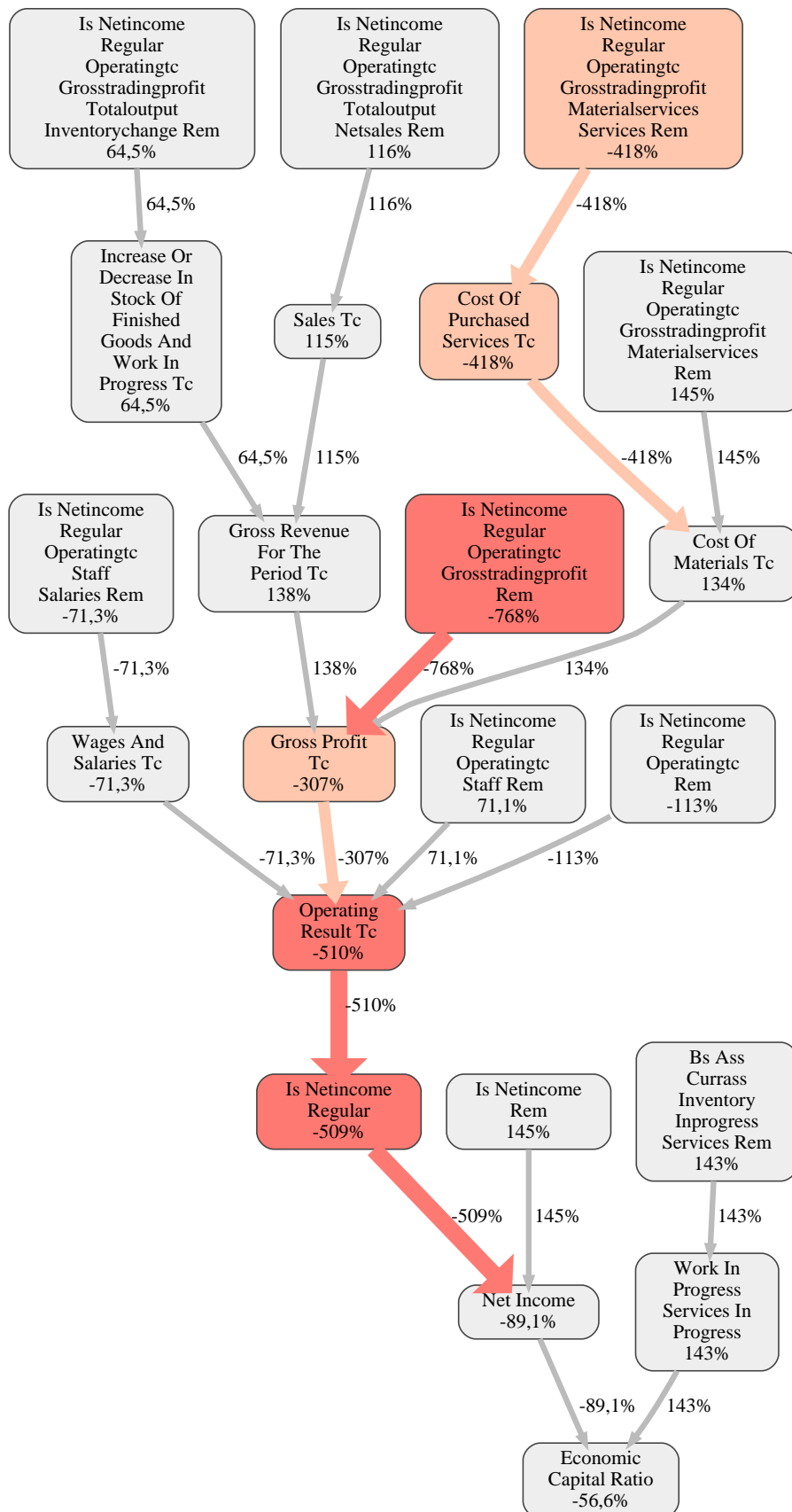

The relative strengths and weaknesses of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 145% points. The greatest weakness of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 768% points.

The company's Economic Capital Ratio, given in the ranking table, is 145%, being 57% points below the market average of 202%.
