



The relative strengths and weaknesses of ANES Bauausführungen Berlin GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ANES Bauausführungen Berlin GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 79% points. The greatest weakness of ANES Bauausführungen Berlin GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 526% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 28% points below the market average of 107%.
