The greatest strength of GP Con GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Rem, increasing the Economic Capital Ratio by 58% points. The greatest weakness of GP Con GmbH is the variable Bs Eqliab Liab Advpaym Rem, reducing the Economic Capital Ratio by 111% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 36% points below the market average of 107%.
