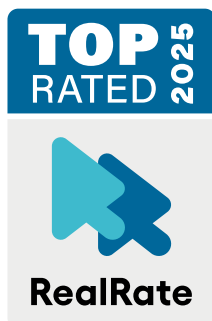

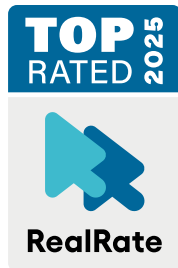

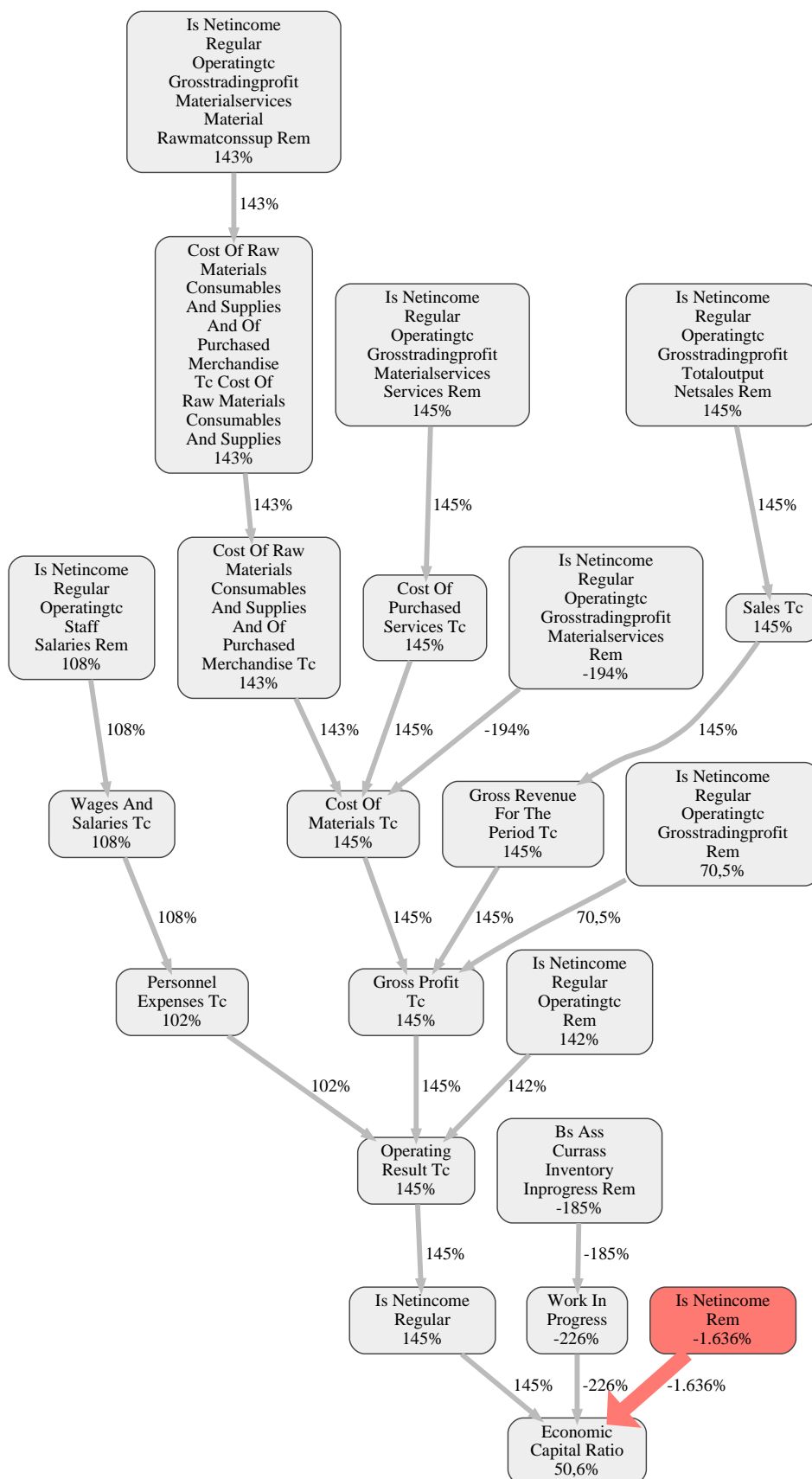

The relative strengths and weaknesses of Bauunternehmung Glöckle Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Glöckle Hoch und Tiefbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, increasing the Economic Capital Ratio by 145% points. The greatest weakness of Bauunternehmung Glöckle Hoch und Tiefbau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 1.636% points.

The company's Economic Capital Ratio, given in the ranking table, is 145%, being 51% points above the market average of 94%.
