

The relative strengths and weaknesses of Ruben Schäfer Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 402% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Bank Balances And Cheques, reducing the Economic Capital Ratio by 848% points.

The company's Economic Capital Ratio, given in the ranking table, is 505%, being 258% points above the market average of 247%.

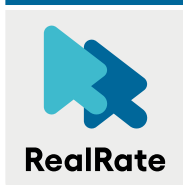
