



The relative strengths and weaknesses of Bien Zenker GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bien Zenker GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 280% points. The greatest weakness of Bien Zenker GmbH is the variable Assets, reducing the Economic Capital Ratio by 2.662% points.

The company's Economic Capital Ratio, given in the ranking table, is 506%, being 259% points above the market average of 247%.
