The greatest strength of Hometryst Bancshares Inc compared to the market average is the variable Loans, increasing the Economic Capital Ratio by 6.3% points. The greatest weakness of Hometryst Bancshares Inc is the variable Deposits, reducing the Economic Capital Ratio by 5.0% points.

The company's Economic Capital Ratio, given in the ranking table, is 14%, being 2.4% points below the market average of 17%.
