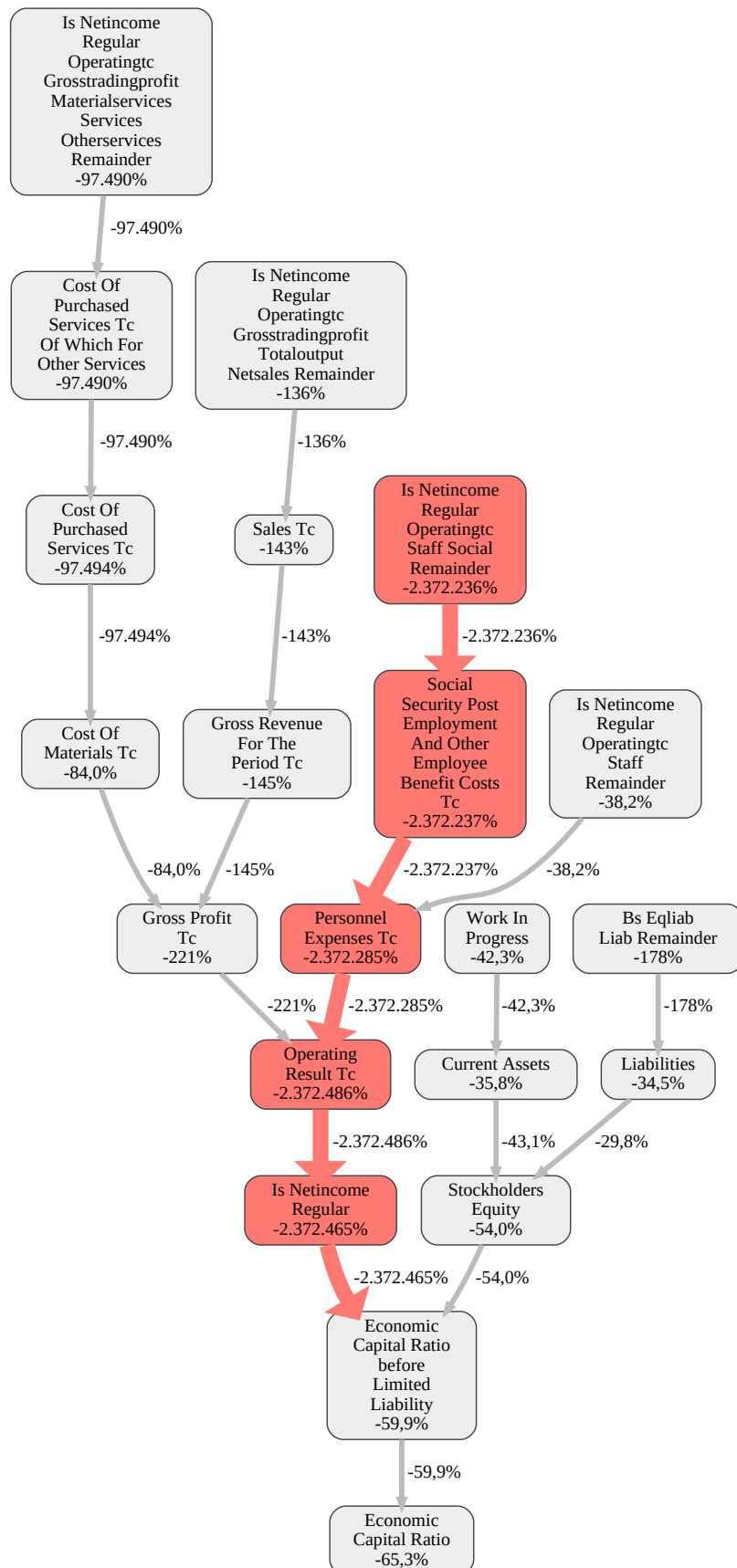




The relative strengths and weaknesses of Arslan Bau Gesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arslan Bau Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 32% points. The greatest weakness of Arslan Bau Gesellschaft mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.486% points.

The company's Economic Capital Ratio, given in the ranking table, is 32%, being 65% points below the market average of 98%.
