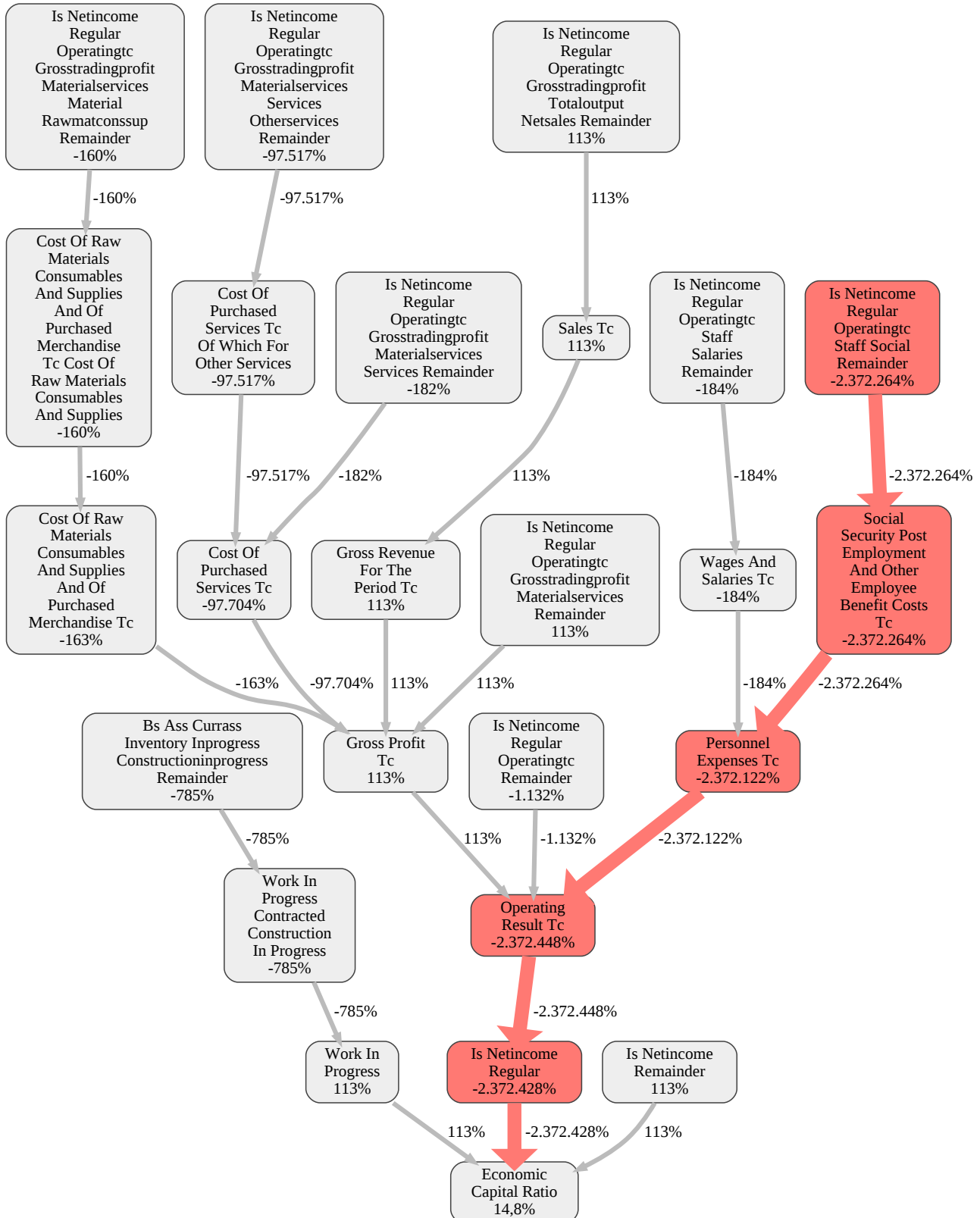

The greatest strength of Wadle Bauunternehmung GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 113% points. The greatest weakness of Wadle Bauunternehmung GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.448% points.

The company's Economic Capital Ratio, given in the ranking table, is 113%, being 15% points above the market average of 98%.
