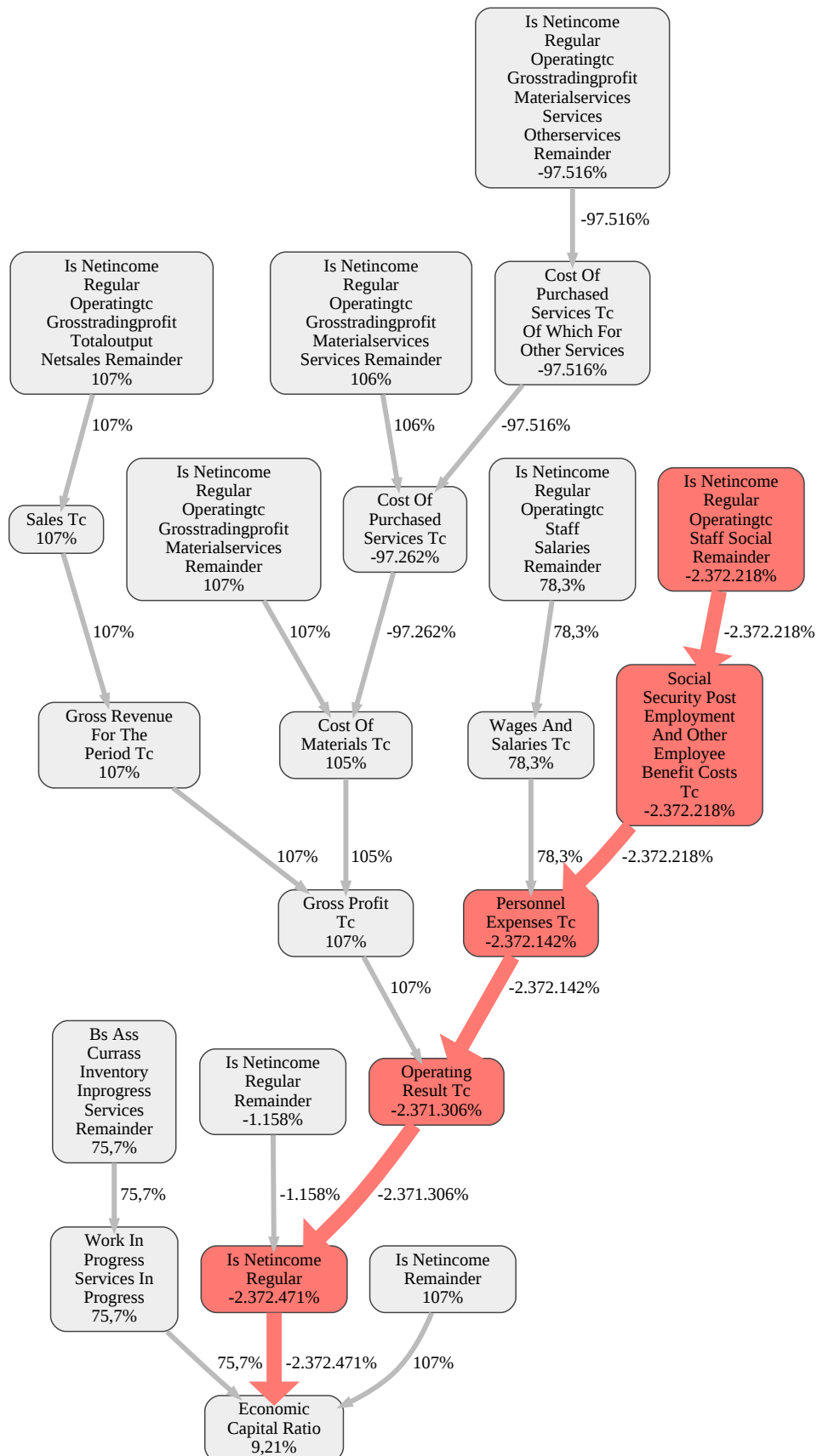




The relative strengths and weaknesses of Josef Pfaffinger Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Pfaffinger Bauunternehmung GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 107% points. The greatest weakness of Josef Pfaffinger Bauunternehmung GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 2.372.471% points.

The company's Economic Capital Ratio, given in the ranking table, is 107%, being 9,2% points above the market average of 98%.
