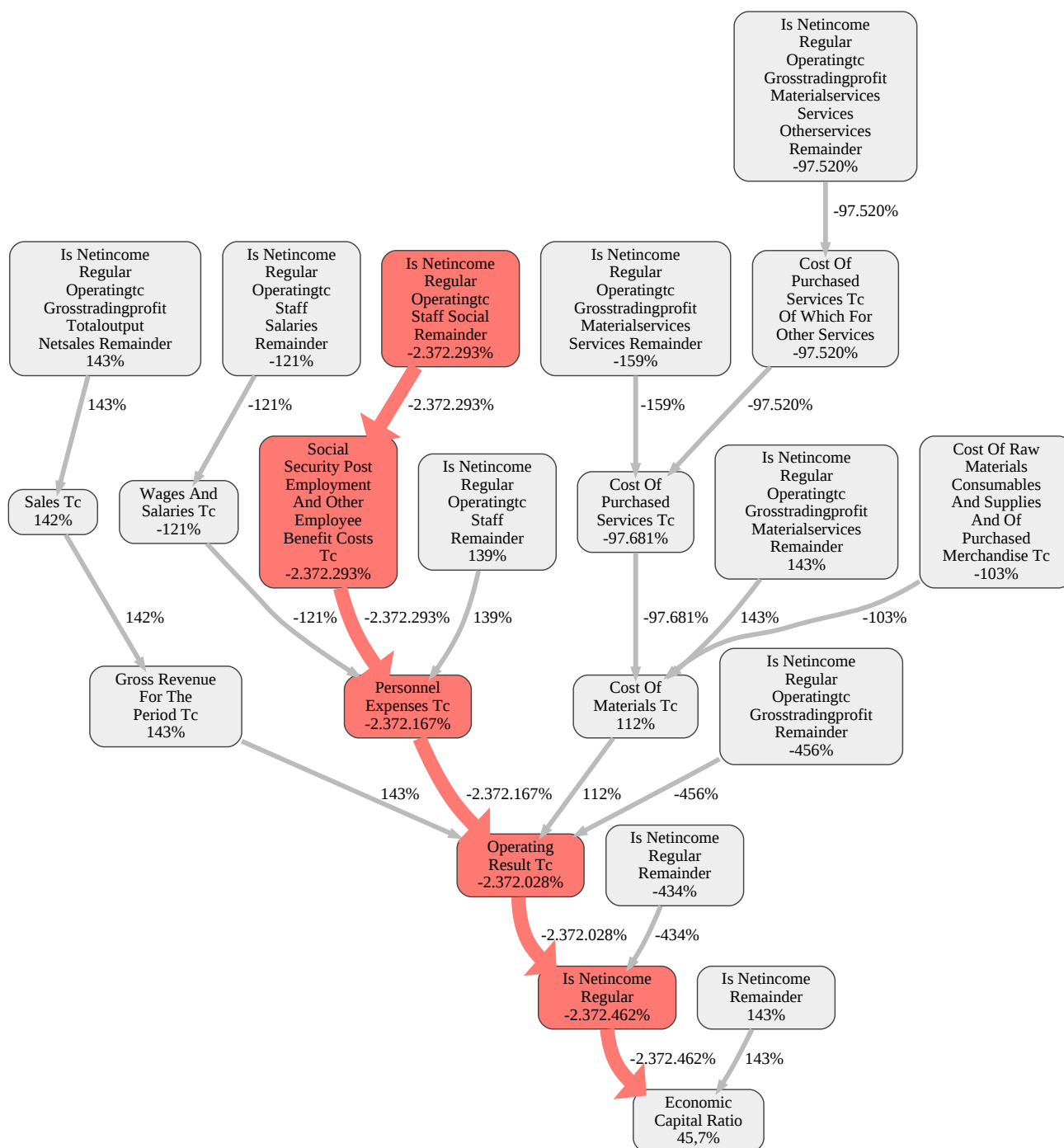




The relative strengths and weaknesses of Dittgen Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dittgen Bauunternehmen GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 143% points. The greatest weakness of Dittgen Bauunternehmen GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 2.372.462% points.

The company's Economic Capital Ratio, given in the ranking table, is 143%, being 46% points above the market average of 98%.
