

The relative strengths and weaknesses of Finsterwalder Bau Union GmbH Sitz Zeckerin are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Finsterwalder Bau Union GmbH Sitz Zeckerin compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Finsterwalder Bau Union GmbH Sitz Zeckerin is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.256% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 0,42% points above the market average of 98%.
