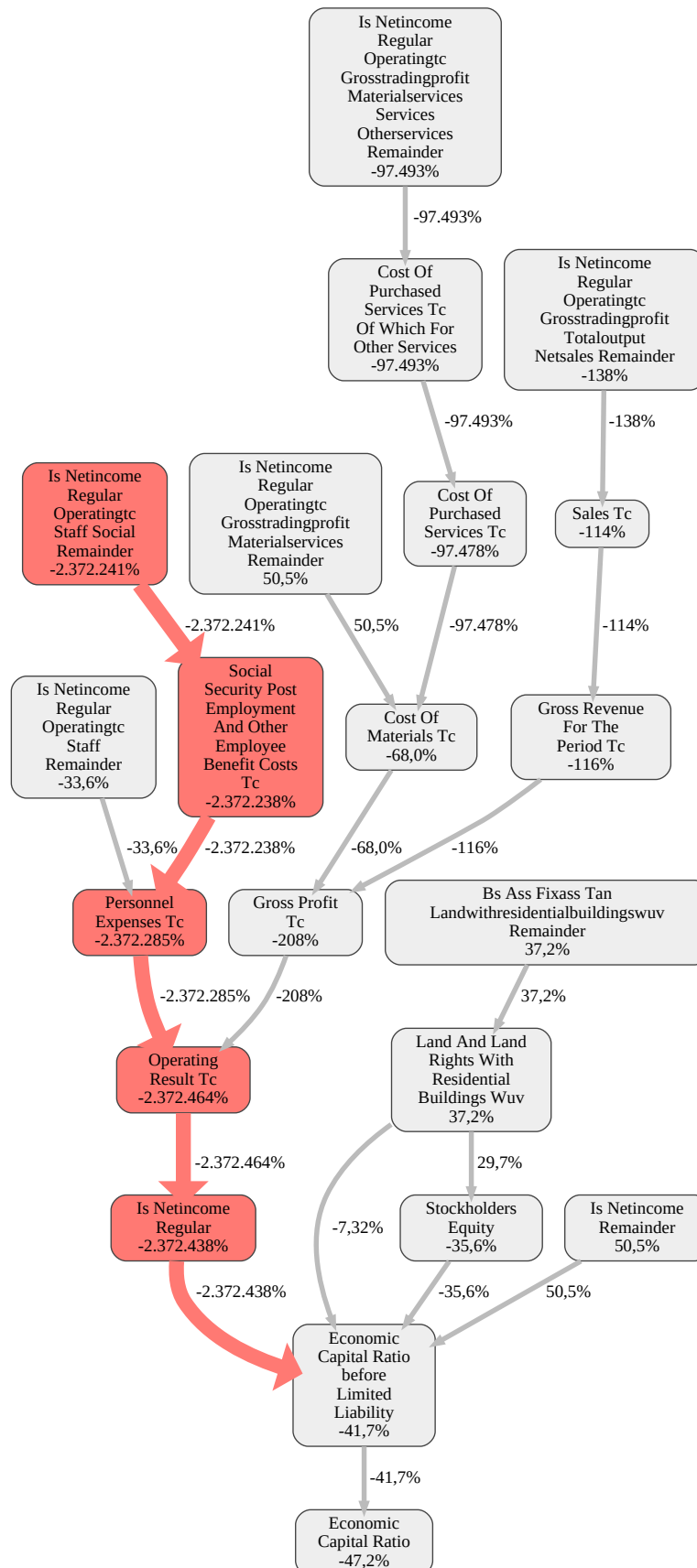




The relative strengths and weaknesses of Herner Gesellschaft für Wohnungsbau mbH HGW are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Herner Gesellschaft für Wohnungsbau mbH HGW compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Herner Gesellschaft für Wohnungsbau mbH HGW is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.464% points.

The company's Economic Capital Ratio, given in the ranking table, is 51%, being 47% points below the market average of 98%.
