The greatest strength of Gesobau Wohnen GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 36% points. The greatest weakness of Gesobau Wohnen GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.458% points.

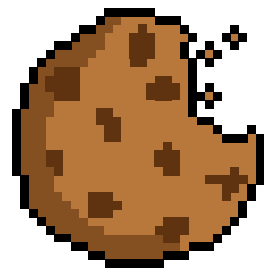
The company's Economic Capital Ratio, given in the ranking table, is 36%, being 62% points below the market average of 98%.
