



The relative strengths and weaknesses of Gewobag Wohnungsbau Aktiengesellschaft Berlin are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gewobag Wohnungsbau Aktiengesellschaft Berlin compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 60% points. The greatest weakness of Gewobag Wohnungsbau Aktiengesellschaft Berlin is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.467% points.

The company's Economic Capital Ratio, given in the ranking table, is 60%, being 37% points below the market average of 98%.
