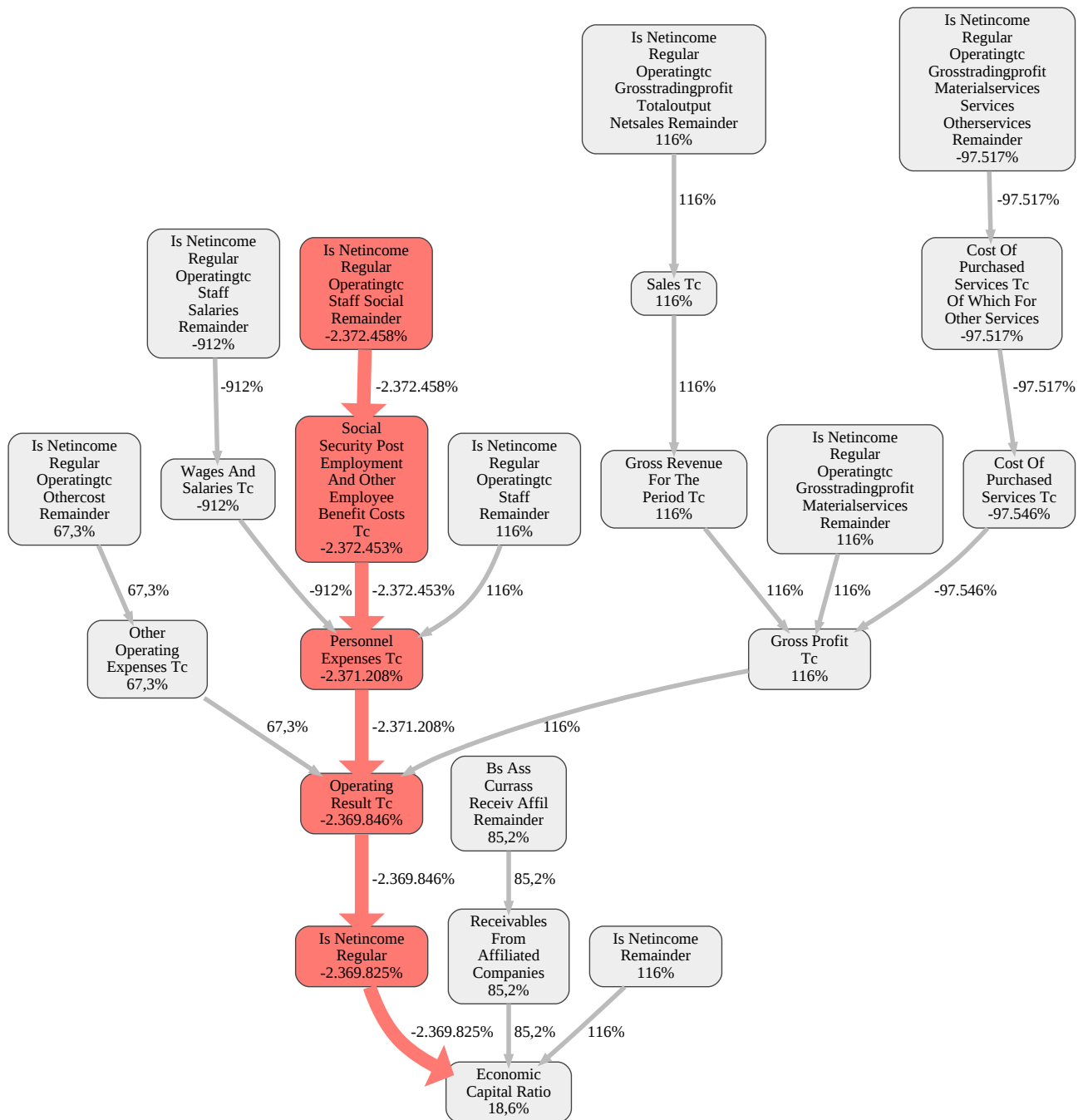




The relative strengths and weaknesses of Degewo Gebäudeservice GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Degewo Gebäudeservice GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 116% points. The greatest weakness of Degewo Gebäudeservice GmbH is the variable Is Netincome Regular Operatingtc Staff Social Remainder, reducing the Economic Capital Ratio by 2.372.458% points.

The company's Economic Capital Ratio, given in the ranking table, is 116%, being 19% points above the market average of 98%.
