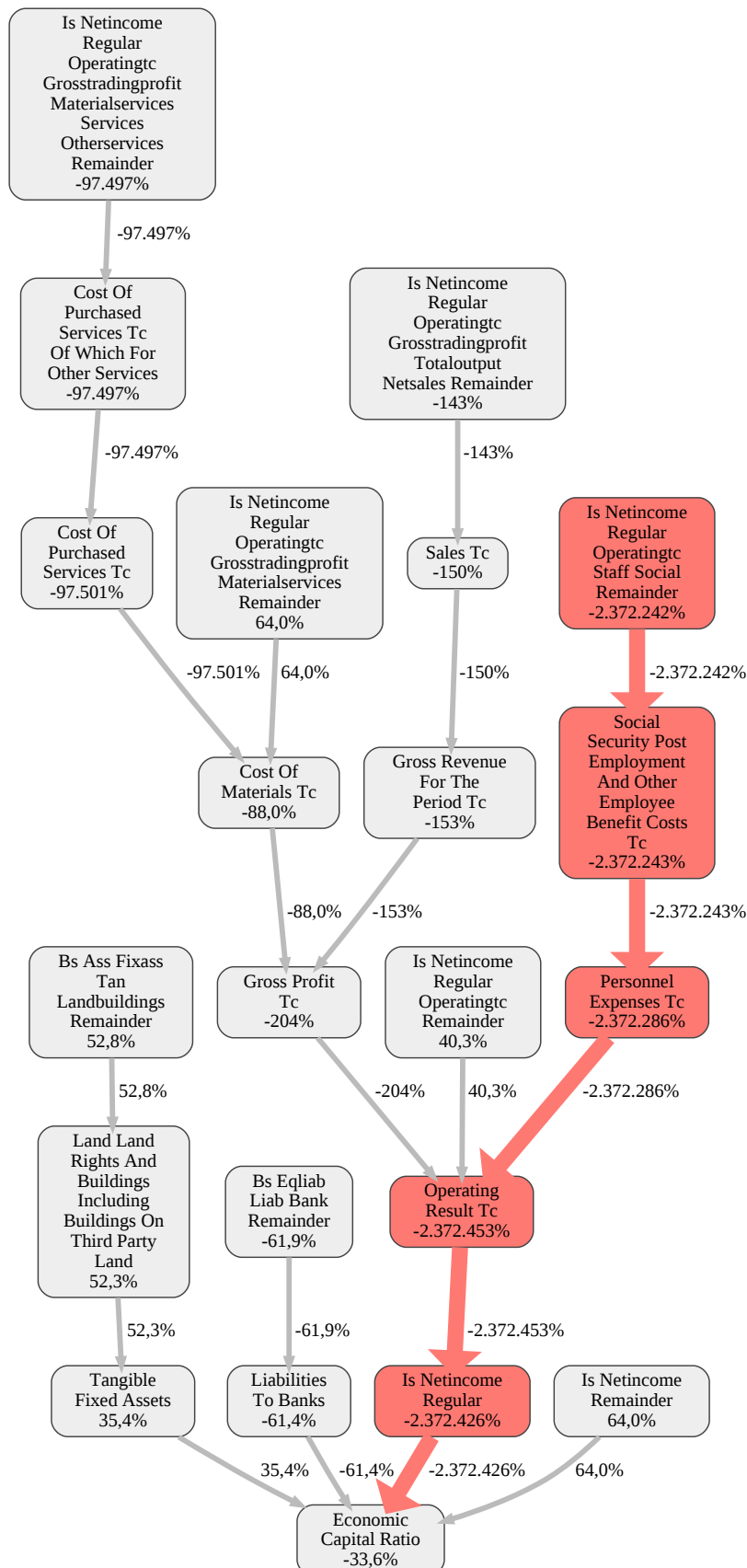




The relative strengths and weaknesses of Gemeinnützige Wohnungsbau GmbH Marburg Lahn are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gemeinnützige Wohnungsbau GmbH Marburg Lahn compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 64% points. The greatest weakness of Gemeinnützige Wohnungsbau GmbH Marburg Lahn is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.453% points.

The company's Economic Capital Ratio, given in the ranking table, is 64%, being 34% points below the market average of 98%.
