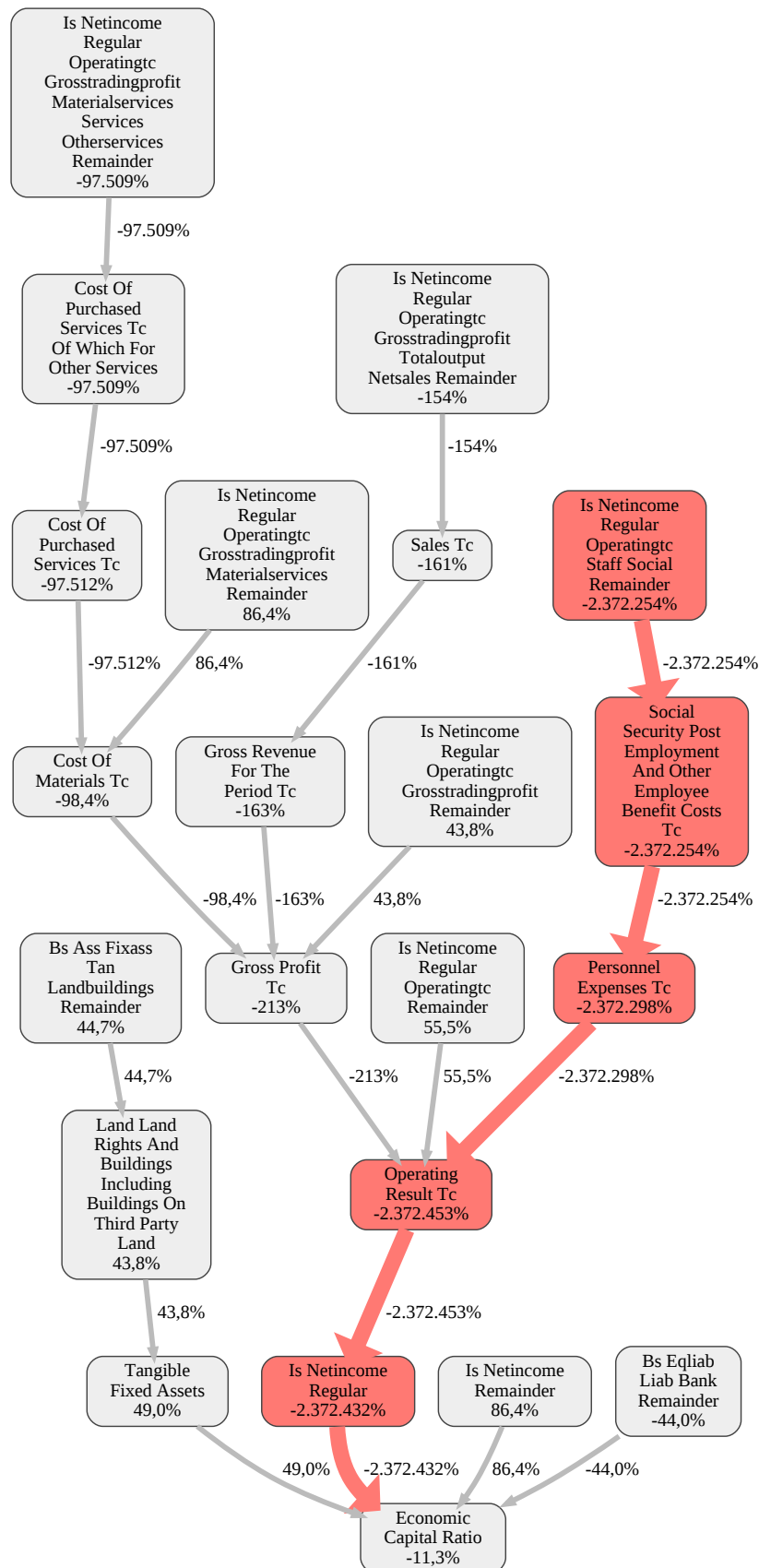




The relative strengths and weaknesses of Wohnungs und Baugesellschaft Wolfen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungs und Baugesellschaft Wolfen mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Wohnungs und Baugesellschaft Wolfen mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.453% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 11% points below the market average of 98%.
