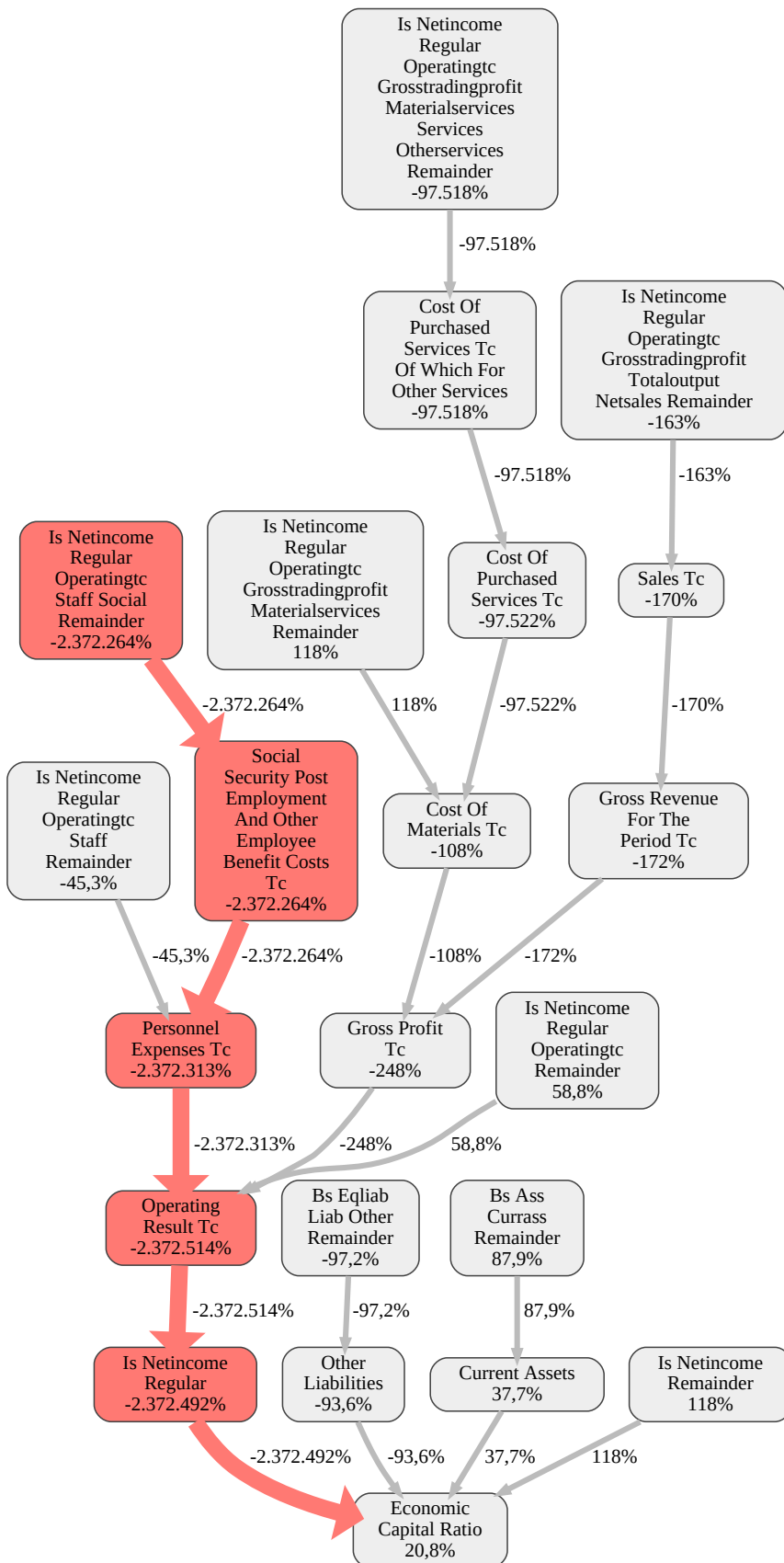




The relative strengths and weaknesses of WiWO Servicegesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WiWO Servicegesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 118% points. The greatest weakness of WiWO Servicegesellschaft mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.514% points.

The company's Economic Capital Ratio, given in the ranking table, is 118%, being 21% points above the market average of 98%.
