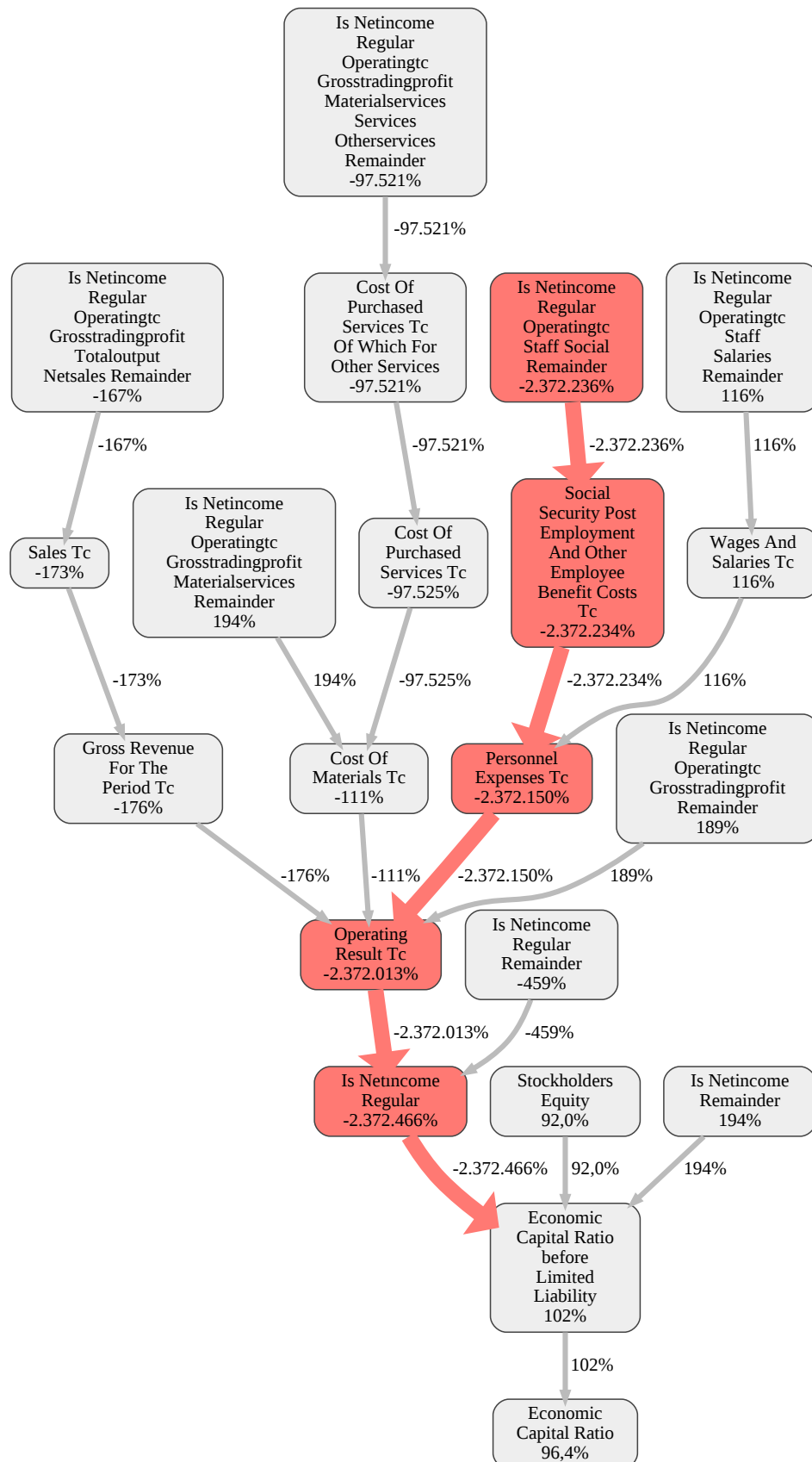




The relative strengths and weaknesses of Laumer Bautechnik GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Laumer Bautechnik GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 194% points. The greatest weakness of Laumer Bautechnik GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 2.372.466% points.

The company's Economic Capital Ratio, given in the ranking table, is 194%, being 96% points above the market average of 98%.
