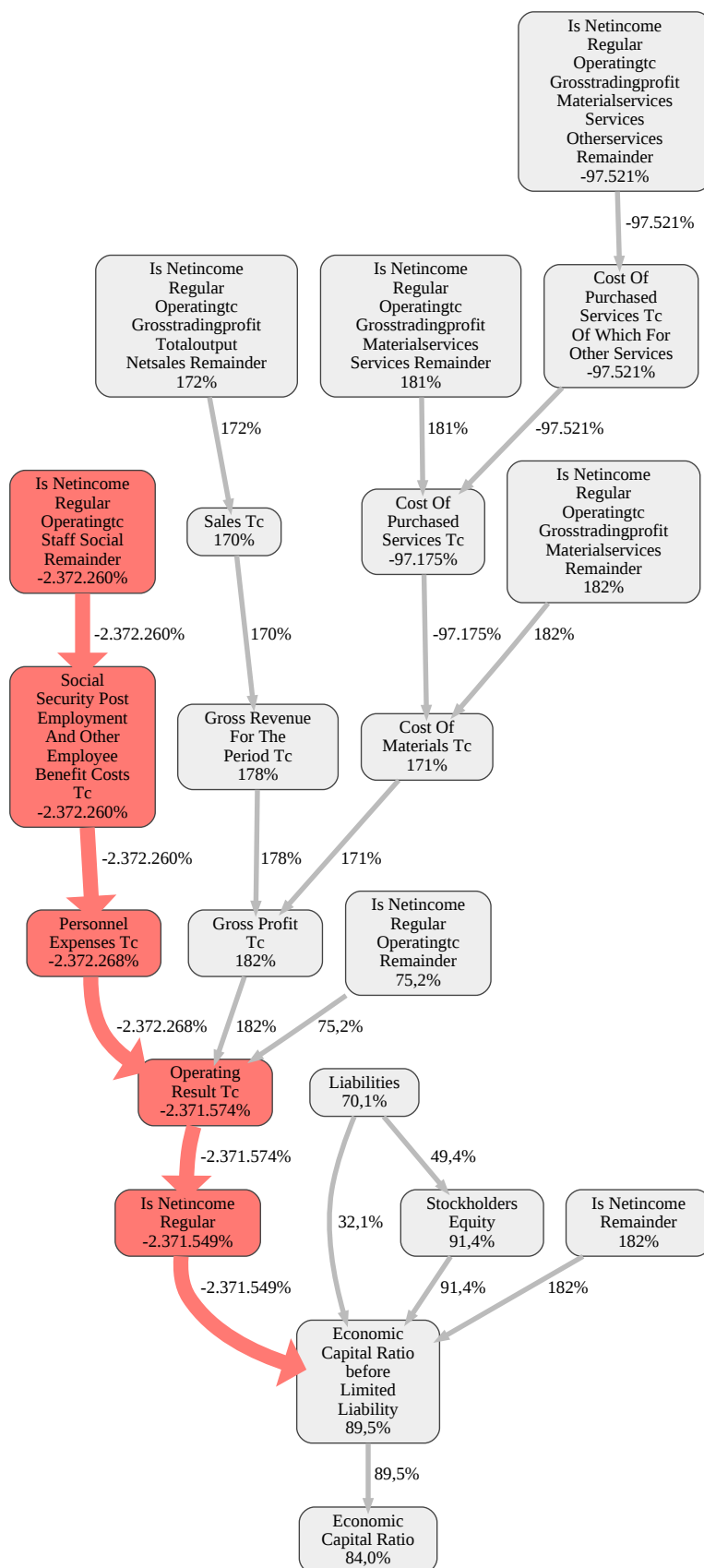




The relative strengths and weaknesses of Bremer AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bremer AG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 182% points. The greatest weakness of Bremer AG is the variable Personnel Expenses Tc, reducing the Economic Capital Ratio by 2.372.268% points.

The company's Economic Capital Ratio, given in the ranking table, is 182%, being 84% points above the market average of 98%.
