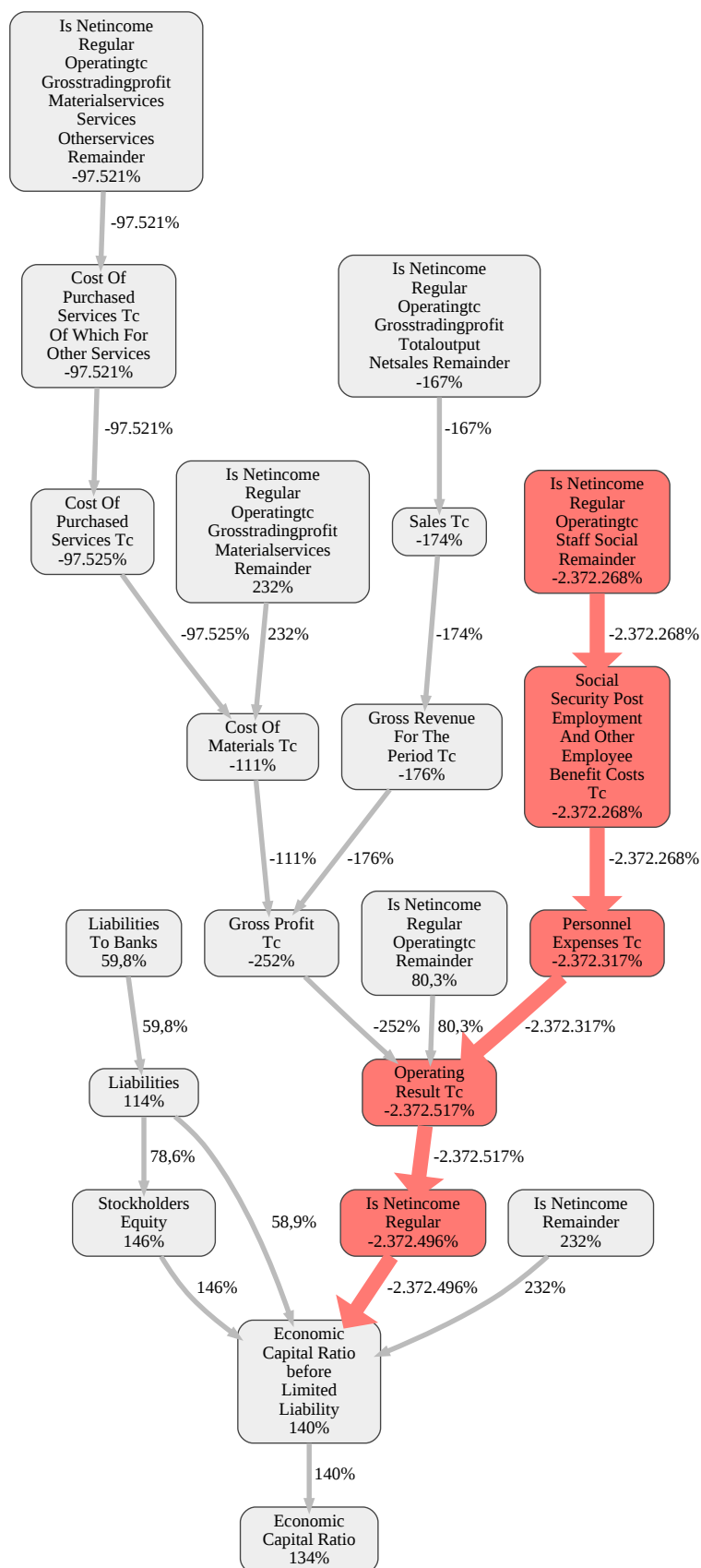




The relative strengths and weaknesses of Takenaka Europe GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Takenaka Europe GmbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 232% points. The greatest weakness of Takenaka Europe GmbH Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.517% points.

The company's Economic Capital Ratio, given in the ranking table, is 232%, being 134% points above the market average of 98%.
