



The relative strengths and weaknesses of Wohnbaugruppe Augsburg Leben GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbaugruppe Augsburg Leben GmbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Wohnbaugruppe Augsburg Leben GmbH Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.471% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 27% points below the market average of 98%.
