





The greatest strength of Gesobau AG Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Gesobau AG Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.494% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 31% points below the market average of 98%.


