



The relative strengths and weaknesses of Pfeiffer GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Pfeiffer GmbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Pfeiffer GmbH Konzern is the variable Personnel Expenses Tc, reducing the Economic Capital Ratio by 2.372.246% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 5,2% points below the market average of 98%.
