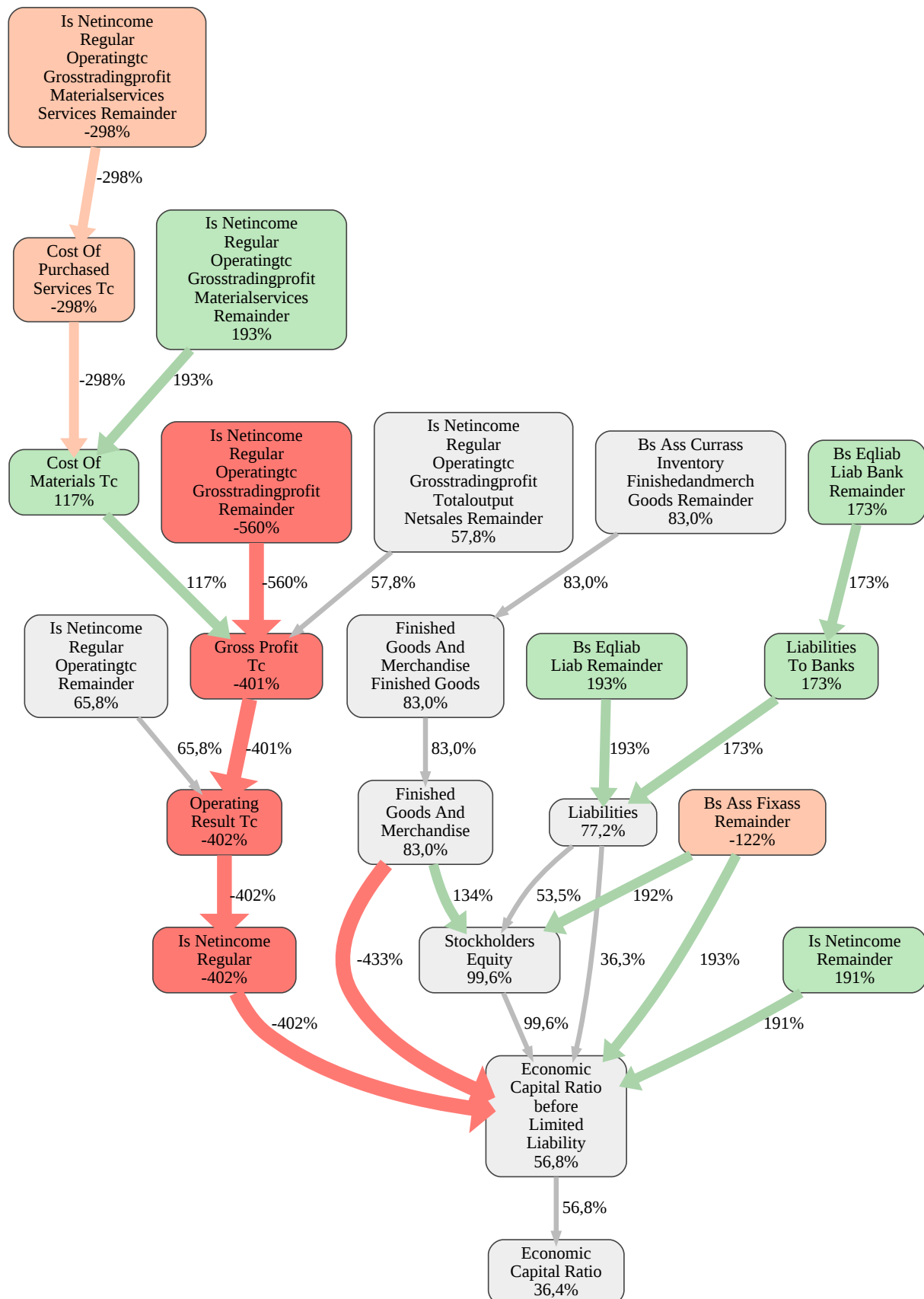




The relative strengths and weaknesses of Nesslerer bau gmbh are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Nesslerer bau gmbh compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 193% points. The greatest weakness of Nesslerer bau gmbh is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 560% points.

The company's Economic Capital Ratio, given in the ranking table, is 193%, being 36% points above the market average of 156%.
